





The Trust shall be called "**AGARAM EDUCATIONAL AND CHARITABLE TRUST**" and its office shall be at Agaram Play School, 104, Nehru Street, M.J. Marriage Hall, Anthiyur, Erode-638501, Tamil Nadu or such other place as the Trustees may decide from time to time.


2. OBJECTS :

The objects of the Trust are:

- a) To establish, run, maintain, takeover management, administer and/or promote Kinder Garden Schools, Elementary Schools, Matriculation Schools, High Schools, Higher Secondary School, Arts Colleges, College of Pharmacy, Nursing College, Engineering College, Medical College, College of Law, Polytechnic, Technological and Research Institution and such other Educational Institutions and to establish the necessary infrastructure like Land, Building, workshop for Teaching and other immovable and movable assets for the students studying in any of such institutions.
- b) To institute and award scholarships, grants, contribution to individual prosecuting studies and contribution to educational institutions imparting general, medical and technical education to the public.
- c) To make donations and/or financial assistance to registered societies or institutions with charitable objects from out of the funds of the Trust, such application of funds to be made in consonance to the provisions of the Income Tax Law, as they are prevailing now and as may be amended from time to time.
- d) To accept donations, grants, presents and gifts, either in cash or in kind or in any other form of assets for the purpose of the Trust and to adopt all lawful course, means and measures for raising funds for the Trust.

- e) And in general to do all such other acts, things and matters as are conducive to the achievements of the objects of the Trust, provided however nothing shall be deemed to include any object which is not a "Charitable Purpose".
- f) Subject to the above said objects of charity, the Trust shall not carry on any activity with the intention of earning profit.

3. TRUSTEES :

The Trust Board shall comprise, a minimum of Twenty six trustees and a maximum of Thirty trustees and shall not be reduced to less than **Twenty six** as a result of unfilled vacancies. The Trust Board shall be competent to transact all and every business of the trust notwithstanding the vacancies remaining unfilled.


The Founder and the permanent trustees reserve the right of appointing one or more Trustees and also to delete the founder, permanent trustees and such other trustees as appointed from time to time.

- a) The Founder Trustee and the permanent trustees shall hold the office till their life time and shall not liable to retire.
- b) In the event of the founder and permanent trustees becoming incapacitated to actively participate in the affairs of the trust due to his/her old age or serious ailment, he/she shall reserve the right to nominate any of his/her legal heirs to represent him/her in the conduct of the affairs of the Trust and such nominated legal heir of such incapacitated trustee shall be vested with all the rights in the conduct of the affairs of the Trust and shall hold office till their life time.







- c) Every trustee, during his/her life time, shall nominate any one of his /her following legal heirs, viz., husband/wife/son/daughter only these or can we add, to succeed him/her to the membership of the trustee after his /her life time. The person already nominated by him from his family will become the trustee of the trust. If he has not already nominated any one, the family members have to nominate one person from the family to become trustee of the trust. In case of disagreement among the family members in nominating a successor, the Board of Trustees will nominate person from the family as trustee of the trust.
- d) If any of the trustees except the founder trustees appointed as above is found to have acted against the interest of the Trust, he/she shall be liable to be removed from the trust. Whenever there shall appear cause as aforesaid, for the removal of a trustee, if a majority of the Trust Board shall, after due deliberation determine, to propose to the General Body the removal of the said trustee, the President in the general body meeting shall announce from the chair such determination of the Trust Board and at the meeting after that at which the said announcement has been made, the proposition shall be submitted to voting. If 2/3rd of the total number trustees and voting at such General Meeting, vote for the removal of such trustee, he shall be removed from the trust.

4. BOARD OF TRUSTEES :

- i. The affairs of the trust shall be managed by the Board of Trustees hereinafter called "Trust Board".
- ii. The Trust Board shall comprise, a minimum 5 trustees and a maximum of 30 trustees and shall not be reduced to less than 5 as a result of unfilled vacancies. The Trust Board shall be competent to transact all and every business of the trust notwithstanding the vacancies remaining unfilled.

- vii. An additional Trustee may be co-opted by the Trustees for the time being in office if considered desirable for the better fulfillment of the objects of the Trust, in consultation, with and as recommended by not less than $\frac{2}{3}$ rd of the total trustees. The period of such trustees shall be determined by the Trust Board.
- viii. The quorum for a meeting of the Trust Board shall be 51% . Five days notice shall be given to the trustees of the Trust Board and such notice shall be sent by local delivery or by courier or such other mode as may be decided by the Trust Board from time to time.
- ix. Any trustee in the trust board may be removed on a resolution passed to that effect by $\frac{2}{3}$ rd majority of the total trustees present and voting in any meeting.

5. PRESIDENT :

1. The President is the head of the trust and shall preside over all the meetings.
2. In accordance with the powers delegated to the President by the Trust Board either generally or specifically, the President shall be in overall management of the Trust and its properties with the assistance of Trustees who are elected in the Trust Board of the Trust.
3. The President shall have power to borrow and spend the funds to such limit for the furtherance of the objects of the Trust as may be fixed by the Board of Trustees from time to time and for the purposes of securing loan from Bank and Financial Institutions, he is further authorised to create charges over the properties and assets of the Trust, whenever it is necessary. He is also empowered to give the Trust's properties as security to the Central or State Government if Government notifications may so requires, subject to ratification by the Trust Board.

8. **JOINT SECRETARY**

The Joint Secretary will exercise the powers of the secretary in his absence together with the responsibility attached to such exercise of powers.

9. **TREASURER**





2. The Board of Trustees shall have the power to receive any donations, contributions in each or in kind and gifts of properties, both movable and immovable.
3. The Board of Trustees shall have power to receive any grants from the Central or State Governments or other Charitable Trusts or Intuitions.




11. **MEETINGS :**


1. The Board of Trustees shall meet as often as is necessary and shall endeavour to meet at least four times in a year. Decision shall be taken by 2/3rd of the trustees present and vote and the President shall have a casting vote in the event of tie, in addition to his own.
2. No business shall be transacted at any meeting unless a quorum is present at the time when the meeting proceeds to business. 51% of the total trustees present in person and entitled to vote shall constitute quorum for any meeting. If within an hour from the time appointed for a meeting a quorum of trustees is not present, shall stand adjourned to the same day in the following week at the same time and place. Even in the adjourned meeting if there is no quorum then the trustees present in that meeting shall constitute quorum. Ten days notice shall be given to the trustees and such notice shall be sent by local delivery or by Courier or such other mode as may be decided by the Trust Board from time to time

12. **TRUST PROPERTY**



- d. Grants, if any, received from the Central or State Governments or other Trusts or Institutions.
- e. Properties, movable and immovables and investments acquired by the Trustees from the Trust Funds. Properties may be endowed by way of gift or donation and the trustees may accept them.

13. **INVESTMENTS :**

The Trustees shall invest the trust funds and administer the Trust properties in the best interest of the Trust and any surplus funds of the Trust shall be invested in accordance with the provisions of section 13(1)(d) read section 11(5) of the Income Tax Act, 1961.

14. **ACCOUNTS AND AUDIT :**

The Trust shall maintain proper accounts and the same shall be closed each year as on 31st March. The financial year of the Trust shall be 1st April to 31st March of every year.

A Receipts and Payments Account and an Income and Expenditure Account for the year ending on 31st March and a Balance Sheet as at 31st March of the year shall be prepared and placed at a meeting of the Trust within six months after the expiration of each financial year.

The Trust shall get the accounts and the Balance Sheet audited by a qualified Chartered Accountant.

Such amendments shall be carried out only with the approval of the Commissioner of Income tax holding jurisdiction over the Trust, where the trust got its registration u/s.12AA of the Income Tax Act, 1961.

17. DISSOLUTION :

If at any time the Trustees are of opinion that they are unable to achieve the objects of the Trust satisfactorily or manage its properties and funds, then the Trustees shall transfer the management of the Trust and its properties to any other Public Charitable Trust or an association of persons having some of its objects similar to those of this Trust. The decision should be implemented by a resolution accepted by not less than three fourth of the total number of trustees.
